To consider and/or approve a a Memorandum of Understanding between Cleveland County Wellness Square and Moore Police Advancement Center.

Cleveland County Wellness Square agrees to pay up to \$6,000.00 funded through ARPA Project #2.013 object code 54825 for Youth Wellness for MPAC for assistance in implementation with a youth wellness event.

MEMORANDUM OF UNDERSTANDING

1. The Memorandum of Understanding (the “MOU”) is made and entered into this 22nd day of June, 2026, by and between the Cleveland County Health Department on behalf of the Cleveland County Wellness Square (“CCWS”) and Moore Police Advancement Center (“MPAC”). CCWS and MPAC shall be jointly referred to herein as the “Parties”.

Cleveland County Wellness Square agrees to:

1. CCWS has implemented a youth wellness program that aims to mitigate negative economic impacts to families due to the COVID-19 pandemic, and to lower Adverse Childhood Experiences (ACES) by connecting parents with community resources.
2. CCWS agrees to pay up to \$6,000 funded through ARPA Project #2.013, object code 54825, for Youth Wellness to MPAC for assistance in implementation with a youth wellness event.

Moore Police Advancement Center agrees to:

1. Hold a youth wellness event for the Moore Police Department that interfaces with the public.
2. Invoice CCWS for the cost of materials for the youth wellness event
3. Provide clean, safe, professional, climate-controlled learning environment(s).

2. This MOU shall represent the entire agreement between CCWS and MPAC. It shall become effective when signed by both parties with the authorization of their governing bodies.
 3. The terms and conditions of this MOU shall be interpreted, determined, and enforced pursuant to the laws of the State of Oklahoma.
