2. Discussion and possible action regarding an Infrastructure report on current projects taking place within the county.

Lisa Painter presented the following report: a) The Sheriff's Office has relocated. Although there were a few minor issues during the transition, operations are now running smoothly.

b) The lighting project for the offices and corridors has been completed, and work is now being extended to the courtrooms and restrooms.

c) There are no new updates regarding the elevator.

d) A start date for the air handler replacement has not yet been determined.

e) Plans are being considered to replace the deteriorating asphalt at the Couch Center with concrete, along with a possible expansion of the rear parking lot.

f) They are currently searching for a tenant for the sixth floor of the Vista Building.

g) Roof replacement work on the south annex is now in progress and is expected to be completed within approximately one to ten days.

h) Several improvements are being evaluated for the fairgrounds arena, including restroom renovations and replacement of the wash bays.

**No new business was presented for discussion or possible action at this time.**

**During Board Member statements and announcements, Mark Braley reminded everyone that Commissioner Jacob McHughes would be developing a plan of action to address future growth and the needs of elected officials. The goal is to create a five- to ten-year plan that will help anticipate future requirements, including storage space, additional courtrooms, and other facility needs. Braley emphasized the importance of having a written plan in place. Chairman Douglas Warr added that an announcement should be made to remind the Budget Board about the initiative.**
