

RESOLUTION #26-1459

CONSIDERATION AND POSSIBLE ACTION UPON A RESOLUTION SELECTING TRUSTEE BANK AND UNDERWRITER, IN CONNECTION WITH THE AUTHORITY’S ANTICIPATED ISSUANCE OF BONDS, NOTES, OR OTHER EVIDENCES OF INDEBTEDNESS IN THE AMOUNT OF NOT TO EXCEED TWO HUNDRED THIRTY MILLION DOLLARS AND NO /100 (\$230,000,000) TO FINANCE ALL OR A PORTION OF THE COSTS OF THE CONSTRUCTION OF THE CLEVELAND COUNTY ARENA PROJECT IN CLEVELAND COUNTY, OKLAHOMA.

WHEREAS, the Cleveland County Recreational and Entertainment Facilities Authority, Cleveland County, Oklahoma (the “Authority”) anticipates the issuance of bonds, notes, or other evidences of indebtedness in the aggregate principal amount not of to exceed Two Hundred Thirty Million Dollars (\$230,000,000) (the “Bonds”) for the purpose of financing all or a portion of the costs of the construction of the Cleveland County Arena Project in Cleveland County, Oklahoma; and

WHEREAS, pursuant to the authorization provided in the Resolution adopted on May 18, 2026, the Authority solicited requests for quotes from local, regional, and national banking and underwriting institutions to determine the best terms and conditions for the issuance and sale of the Bonds; and

WHEREAS, the Authority has reviewed the proposals received and has determined that the proposal submitted by _____, as trustee bank, and _____, as underwriter, is in the best interests of the Authority the anticipated issuance of the Bonds.

NOW THEREFORE BE IT RESOLVED BY THE TRUSTEES OF THE CLEVELAND COUNTY RECREATIONAL AND ENTERTAINMENT FACILITIES AUTHORITY:

Section 1. The Authority hereby selects _____ to serve as trustee bank and _____ to serve as underwriter in connection with the anticipated issuance of the Bonds.

Section 2. This Resolution shall become effective immediately upon its adoption.
