**WHEREAS**, the COUNTY and SUBRECIPIENT have agreed to amend this agreement as follows:

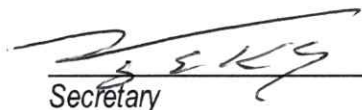

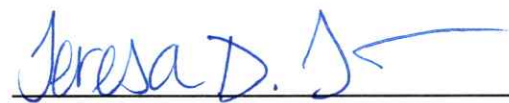
